Re: Annual Recertification Ad Litem for Children and/or Parents in CPS cases

Section 107.004 of the Family Code requires that an attorney who is on the CPS appointment list maintained by the court to complete <u>annually</u> at least three hours of CLE relating to the representation of a child and or parent in a Child Protective Service Case. If you wish to represent both children and parents it is a total of 6 hours of CLE.

The District judges will be updating this list annually, beginning in January of 2019. To remain on the list please send proof of hours to our office **prior to December 20th**. The three District Judges want to thank each of you for representation of these very special children and or their parents in the past and hope that you will continue to provide these services to the citizens of our five counties.
